

## *2021 Annual Meeting Notice and Information*

Dear GPCA Member:

Due to the continued COVID pandemic, the Great Pyrenees Club of America's Board of Directors has postponed the 2020/2021 GPCA National Specialty.

However, per the Bylaws, the club must have an Annual Meeting:

### *Article II - MEETINGS*

*Section 1. ANNUAL MEETING. The Annual Meeting of the Club shall be held on or between the last week-end in March and the first week-end in May in conjunction with the Club's Annual Sanctioned Match, or Specialty Show, if possible; at a place, date and hour designated by the Board of Directors. Written notice of the Annual Meeting shall be mailed by the Secretary to each member at least 30 days prior to the date of the meeting. The Quorum for the Annual Meeting shall be 10% of the full members in good standing.*

The Board of Directors will be utilizing Zoom teleconferencing for this year's Annual Meeting as we are unable to meet in person.

The Annual Meeting will take place on May 1, 2021, at 5 pm, EDST. This meeting will be abbreviated. It will only include the following reports: President's, Vice President's, Secretary's, Treasurer's, Judge Selection Committee for the 2023 GPCA National Specialty Judge, and the 2020/2021 National Specialty. No roll call will be taken. No Unfinished or New Business will be entertained as any vote would be unverifiable. Members may connect via the Zoom link attached. We are grateful that Bret Zacher has agreed to moderate for us again this year. This call will be recorded for internal GPCA record keeping.
